Skripsi yang berjudul “Analisis Pelaporan Dana Kampanye atas Kepatuhan, Transparansi, dan Akuntabilitas Sebagai Dasar Good Political Party Governance (Studi Kasus Partai Politik Peserta Pemilu Serentak 2019 Kabupaten Jombang)” ini merupakan hasil penelitian kualitatif yang bertujuan untuk menjawab pertanyaan tentang bagaimana Pelaporan Dana Kampanye dan Analisis Kepatuhan, Transparansi, dan Akuntabilitas Pelaporan Dana Kampanye pada Partai Politik Peserta Pemilu Serentak 2019 Kabupaten Jombang.

Metode yang digunakan dalam penelitian ini adalah kualitatif. Peneliti mengumpulkan data melalui wawancara dengan beberapa Informan Kunci dari Komisi Pemilihan Umum (KPU) Kabupaten Jombang, serta melalui data laporan hasil audit dana kampanye.

Permasalahan yang dikaji dalam penelitian ini adalah partai politik dituntut untuk melakukan pembenahan secara fundamental dengan melakukan pengungkapan pertanggungjawaban pelaporan dana kampanye melalui kepatuhan, transparansi, dan akuntabilitas menuju tata kelola partai yang baik, serta untuk kembali mendapatkan kepercayaan dari masyarakat. Adapun objek penelitian adalah Komisi Pemilihan Umum (KPU) Kabupaten Jombang.

Hasil penelitian menunjukkan bahwa Partai politik peserta pemilu serentak 2019 Kabupaten Jombang sudah melaporkan dana kampanye secara patuh, transparan, dan akuntabel.

This essay entitled "Analysis of Campaign Fund Reporting on Compliance, Transparency, and Accountability as the Basis for Good Political Party Governance (Case Study of Political Parties Participating in the 2019 Simultaneous Elections in Jombang Regency)" is the result of qualitative research that aims to answer questions about how to report campaign funds and Analysis of Compliance, Transparency, and Accountability of Reporting Campaign Funds to Political Parties Contesting the 2019 Concurrent Elections in Jombang Regency.

The method used in this research is qualitative. Researchers collected data through interviews with several key informants from the General Election Commission (KPU) of Jombang Regency, as well as through data on the results of the campaign fund audit.

The problem examined in this study is that political parties are required to make fundamental improvements by disclosing accountability for campaign fund reporting through compliance, transparency and accountability towards good party governance, and to regain the trust of the public. The object of research is the General Election Commission (KPU) of Jombang Regency.

The results showed that the political parties participating in the 2019 simultaneous elections in Jombang Regency had reported campaign funds obediently, transparently, and accountably.
