Penelitian ini bertujuan untuk mengetahui implementasi *hospital governance* yang diukur dari pemeriksaan audit operasional. Salah satu hal yang dapat mewujudkan prinsip-prinsip *good corporate governance* yaitu dilihat dari kinerja operasional di setiap unit rumah sakit, baik kinerja dalam pencapaian tujuan dan kebijakan Rumah Sakit Airlangga, serta pencapaian secara efisien, efektif, dan ekonomis, serta kesesuaian antara kinerja yang telah dicapai dengan kriteria yang telah ditetapkan.
